## **Generic Risk Assessment – Cooking & campsites**

Next review - Nov 2023

Specific campsite risk assessments or information is available for many sites. And is provided if necessary to leaders before or during the event.

Issues that we have experienced on events over the years include:

- Sickness, tummy bugs can be as a result of dehydration, lack of salt, poor personal hygiene. Can result is participants needing to go home in middle of night.
- Cuts from using pen knives has resulted in participant needing to go to hospital for stitches in hand
- Foot puncture participant standing on a tent peg that had been run over by mower
- Burns picking up hot metal (pot, handle, windshield)
- Animal attacks at night for food or rubbish bags. Clothing and food damaged or stolen. Coats with snacks in pockets taken. Tents damaged.
- Stoves or pots with hot liquid being dropped or knocked over.
- Student tripped/slipped and broke their nose.

## **On-site & overnight supervision.**

Leaders are provided with maps of campsites, fire evacuation procedures, and arrangements for overnight supervision or help.

Leaders explain to their teams, what to do in case of fire, burns, scalding or sickness at night.

Event manager is 'on-call' overnight and keeps their phone switch on / not on silent. Teams are shown where to find staff van/car/tent and can use their emergency mobile to call the event manager.

Never assume participants have remembered how to cook safely.</li> <li>Always stay with students on first evening to see cooking and cleaning of stoves for dinner / dessert and hot chocolate.</li> <li>Breakfasts should be boiling of water only so teams can start 'cooking' early.</li> <li>Never allow cooking at lunchtime. Other lunch options must be checked for.</li> <li>Ensure there is appropriate provision for the immediate treatment of burns when stoves are used. Bottle of water nearby.</li> <li>The placement of all stoves must take into account the need for continuous observation, the safety of all campers and the risks to any tents and vehicles in the locality.</li> <li>Ensure use of stoves is supervised at all times by either school staff, event staff and event manager.</li> <li>Training to be given on correct operation of stoves, fuelling and refilling.</li> <li>Agree Fire Procedures with staff and Participants</li> <li>Fulfil any site obligations to run or take part in fire drills</li> <li>Ensure all leaders are aware of fire evacuation routes</li> <li>Firefighting equipment should only be used by competent leaders and only in situations</li> <li>which do not delay appropriate evacuation and which do not put them at risk of unnecessary harm</li> <li>Ensure leaders have access to the list of people in the group at night</li> </ul>
